

benefit from a 'How to Winterize Your Vessel' clinic!

Please welcome Chuck Sullivan as our new Administration Officer, I'll be assisting him with our upcoming dinner events for this calendar year as he gets his sea legs and a few events under his belt.

Our bridge continues to discuss on how to retain and attract new members which is the priority. It would be helpful to have input from our members on what aspects of the club are most beneficial - vessel safety checks, clinics such as MOB drills or maintaining propane systems. Group cruising plans did not materialize this past season so let us know what thoughts come to mind on sailing or cruising ideas.

This is a good time of the year to check out your vessels, review your inventory and currency of safety devices. This past year I had my propane system professionally assessed and updated to meet current standards which my system was sorely out of date. Additionally, I had a 'smoked' out AC outlet which prompted another professional assessment – that will be a larger project this winter to plan and design a likely near-complete replacement of the AC/DC interior wiring. The previous owner had quite a bit of adding runs to components that either no longer work, or are needed or are simply dead runs. I don't think it can be overstated that the battery and electrical systems are the most critical systems to be continually monitored.

That being said, I hope I'll see a good many of you at our November dinner meeting and if not, hope you all have a wonderful holiday season!



If your last name starts with S-Z, please bring a dessert.





America's Boating Channel[™] Fire Extinguisher Regulations



In 2022, the Coast Guard amended portable fire extinguisher rules for recreational vessels in the U.S., making it easier and less costly for millions of boat owners to maintain the onboard fire protection equipment that they need.

The rules do not change the number or types of extinguishers required on board but do simplify inspection and record-keeping requirements. The simplified rules also are now published with other recreational boating rules, making it easier to identify them.

America's Boating Channel video <u>"Fire Extinguisher Regulations"</u> offers an overview of the rules that separates commercial and recreational vessel fire protection requirements. It will help you learn how to ensure that all required portable fire extinguishers comply. Also featured are tips for preventing onboard fires in the first place.

If you need a refresher on classifications and carriage requirements for marine fire extinguishers, the channel offers a second video titled <u>"Fire Extinguisher Standards."</u> It offers tips for placing and servicing fire extinguishers, and explains the acronym PASS. Above all, ensure that the proper number of functional fire extinguishers are on board, readily accessible and that all responsible adults on board know to pull, aim, squeeze, and sweep.

U.S. Coast Guard approved marine-type fire extinguishers fully charged and in good and serviceable condition are required on recreational boats where the engines or fuel system could pose a fire hazard. Good and serviceable means that a fire extinguisher aboard a recreational vessel is properly charged and reads charged if it has a pressure gauge reading or charge indicator, that the extinguisher has a pin lock that is firmly in place, that it does not show visible signs of significant corrosion or damage and has a discharge nozzle that is clean and free from obstructions. Disposable dry chemical extinguishers expire 12 years after their date of manufacture, and rechargeable extinguishers expire annually unless maintained by a certified technician.



Let's start the year by getting our life jackets ready for the 2024 boating season. If you cleaned and inspected your life jackets before storing them for winter storage, you should know how many need to be replaced. Which brings us to our topic of life jacket labels. You may be unaware of the new labeling system if you have not purchased a life jacket recently. Type I, II, III and IV labeling was removed by the U.S. Coast Guard from the Code of Federal Regulations in 2014, but it is taking several years for the legacy designations to be phased out.



To help boaters understand the current labeling system, Season Four of America's Boating



Channel offers the video "<u>Life Jacket Labels</u>" in which you are introduced to the simplified labels that contain less writing and more icons.

Regardless of your age or experience level, data shows that life jackets save lives. So don't hesitate to replace older life jackets. 
